

Call for Expressions of Interest

Strengthening Systems for Safer Childbirth

Collective action to accelerate progress in ending preventable maternal deaths

MSD for Mothers is launching a new multi-sectoral initiative that aims to accelerate progress towards Sustainable Development Goal (SDG) 3.1 by investing in locally-led collective action to strengthen health systems. We are seeking Expressions of Interest from organizations with roots in sub-Saharan Africa or Southeast Asia that will work in coalition with local partners across sectors – government, private and/or civil society – to implement and evaluate evidence-informed solutions that will result in a measurable and sustainable reduction in maternal deaths and, by extension, stillbirths and newborn deaths, in specific geographic areas defined at the state, district, county or city level.

The COVID-19 pandemic has stretched national health systems to a breaking point, hindered access to maternal health services and worsened maternal health outcomes.² At a time when funding and resources for maternal health are under pressure, the global health community must work collectively in support of locally driven sustainable solutions to augment health system capacity, increase health system efficiency, responsiveness and resiliency and improve maternal health outcomes.³ **Strengthening Systems for Safer Childbirth** will create a co-funding and community of practice platform that supports local implementing coalitions.

Expressions of Interest will state the leading challenges to achieving sustained improvements in maternal health in the select geography, as identified by women and girls living in that region, and propose place-based solutions that local organizations will drive, building on local strengths. The focus should be on improving access to quality maternal health services, informed by women's needs and preferences. Proposed solutions may involve high-quality integrated service delivery including family planning, strengthening networks of care, data connectivity and digital inclusion, client engagement and community support, and/or financing and affordability of care.

Each coalition of organizations submitting an Expression of Interest should consider how to:

- Integrate contributions from the local private sector care providers, innovators and entrepreneurs into health systems to augment health system capacity and improve maternal health outcomes
- Deploy scalable solutions that strengthen networks of care and directly address local health system challenges and gaps that prevent women from receiving safe, high-quality, coordinated and respectful care across the pregnancy, childbirth and postpartum continuum, regardless of where they seek care. This includes engaging sectors beyond health that affect health (e.g., WASH, education, gender, etc.)
- Collaborate and coordinate with government as well as help break down silos to create more resilient ecosystems for health
- Incorporate the expressed needs, recommendations and leadership of women and girls who are most at risk of maternal mortality and help to advance more equitable maternal health outcomes
- Unify and catalyze multistakeholder action to harness innovative approaches, shared learnings and best practices that improve maternal health outcomes
- Leverage additional sources of funding and creative financing models (e.g., pay for performance, blended financing, public-private partnerships) to support sustainability

Expressions of Interest are due on November 15, 2021. On December 15, 2021, we will invite a limited number of applicants to develop full proposals. An external advisory committee will help assess applications.

MSD for Mothers expects to award a select number of three-year grants, of up to \$1M a year, to the initial cohort of Strengthening Systems for Safer Childbirth coalitions in May 2022.

BACKGROUND

MSD for Mothers is our company's initiative to help create a world where no woman has to die while giving life. We collaborate across sectors – working with governments, community-based and non-governmental organizations, patient groups, professional associations, UN agencies, research institutions, social entrepreneurs and other businesses – to improve the health and well-being of women during pregnancy, childbirth and the postpartum period. When a mother is healthy, receives high-quality maternity care and has a safe delivery, we set the foundation for children, families, communities and societies to thrive for generations to come. Since our launch in 2011, we have reached more than 13 million women through programs promoting safe, high-quality, respectful care.

MSD for Mothers will build on its 10 years of experience, learnings and success in catalyzing innovative public-private partnerships – including Saving Mothers Giving Life (a comprehensive health system strengthening initiative with the U.S. government); the MOMS Initiative (an innovative financing collaboration with the U.S. International Development Finance Corporation); Safer Childbirth Cities (a collaboration with eight co-funders to improve maternal health equity in the U.S.); and Project CHAMPION (a collaboration with the WHO and Ferring Pharmaceuticals to address postpartum hemorrhage) – to shape and implement this new initiative.⁴

THE STRENGTHENING SYSTEMS FOR SAFER CHILDBIRTH INITIATIVE

What will coalitions do? | Multi-sector coalitions will identify the most serious gaps in health system response that are preventing women from receiving safe, high-quality, coordinated and respectful care and implement tailored solutions to address them. Proposed activities should build on local strengths and leverage pre-existing investments and programs, respond to community needs, advance more equitable maternal health outcomes, reflect the inclusion and engagement of women most affected by maternal mortality, integrate the local private sector and be evidence informed.

What will coalitions achieve? | Coalitions should focus on sustainable solutions to make measurable strides in reducing maternal mortality. Specifically, coalitions should support health systems to consistently deliver quality care which will generate broad benefits, including improved health outcomes for all pregnant women and new mothers, improved patient satisfaction with maternal health care and more equitable access to quality care across mixed (public, not-for-profit and private) health systems.

Who will be part of these coalitions? | MSD for Mothers welcomes coalitions that include organizations from across sectors and disciplines. Successful coalitions will leverage the reach, resources, expertise and innovation from the local private health sector – from private health providers who deliver antenatal and childbirth services to local entrepreneurs who bring innovation to service delivery through data, financing, digital platforms, transport and coordination systems, logistics, etc. – to improve maternal health, advance more equitable maternal health outcomes and help save more women's lives. The local private health sector is often an untapped, valuable resource to help augment health system capacity and improve health system efficiency, responsiveness and resiliency – critical to achieving better patient outcomes, meeting the SDGs and realizing universal health coverage.⁵

How will coalitions work with MSD for Mothers and others? | The coalitions selected to participate in the Strengthening Systems for Safer Childbirth initiative will receive funding through grants or other mechanisms (for example, blended financing) from MSD for Mothers and/or other co-funders of the initiative. These coalitions will participate in a Community of Practice to facilitate shared learning and support and generate evidence to demonstrate impact and potential for sustainability at scale.

CALL FOR EXPRESSIONS OF INTEREST

MSD for Mothers is seeking Expressions of Interest (EOI) from coalitions mobilized to implement solutions to reduce maternal deaths in a specific geographic area with high maternal mortality. The EOI should be submitted by a lead organization and include the names of organizations that will be members of the coalition. **Preference will be given** to coalitions based in states, districts, counties or cities within these focus countries - Kenya, India and Nigeria – but other countries in sub-Saharan Africa will also be considered.

Members of coalitions should:

- Be actively engaged in efforts to improve maternal health that have demonstrated impact
- Have helped advance maternal health equity through meaningful integration of women's needs, preferences and perspectives in the design, implementation and evaluation of solutions

- Have experience and mechanisms in place for soliciting community input and feedback and integrating community-driven solutions into programs
- Have a track record of successfully engaging with governments, public health systems, private sector and/or other relevant stakeholders
- Be committed to sustaining their programs/initiatives, including willingness to experiment with innovative investment models to ensure financial sustainability
- Leverage digital technology as part of capacity building to enable continued performance improvement and program responsiveness, as well as to promote accountability in delivering results
- Be willing to share data transparently to understand measurable results and contribute to ongoing real-time learning
- Be open to actively participating in a Community of Practice (e.g., sharing learnings, successes, failures, best practices, etc.)

To submit an Expression of Interest, please prepare a concise response (three pages maximum in Microsoft Word plus an appendix as noted) that answers the following questions and is included with a completed Request for Information Form (see pg. 8):

- 1. What is your proposed geographic focus area and what are the characteristics and drivers of maternal mortality and morbidity in that region?
- 2. What current efforts are underway to address these drivers? (*Please limit your response to questions 1 and 2 to no more than half a page.*)
- 3. What solutions, interventions or activities do you propose to introduce to accelerate progress?
- 4. How does your suite of solutions complement and ultimately link with other efforts (including those in the public sector) to advance equitable access to high-quality, safe, respectful maternal health care?
- 5. How will your proposed intervention(s) integrate the local private sector to strengthen health systems?
- 6. What experience and expertise does your organization have to develop and implement these solutions? (*The response to this question may be included in an appendix.*)
- 7. Please complete the following table describing the organizations you propose including in your coalition and why? (Please include all the organizations that will have an active role. This table may be included in an appendix.)

- 8. How do you plan to measure and demonstrate results and impact on maternal health and what are examples of the types of indicators you may use?

Following the review of EOIs, MSD for Mothers, with input from an external advisory committee, will identify a group of finalists and invite them to submit a full proposal and budget. Detailed budgets are not required at this



stage. MSD for Mothers expects to award a select number of three-year grants, of up to \$1M a year, to the initial cohort of Strengthening Systems for Safer Childbirth coalitions.

Note: The initiative will only fund one coalition in a particular state, district, county or city. Individual organizations may be included in more than one EOI, including EOIs from the same geography.

ELIGIBLE ORGANIZATIONS

MSD for Mothers is able to provide funding to non-governmental and for-profit entities. Organizations may be headquartered in the U.S. or other countries but must have operations in the country selected for the Strengthening Systems for Safer Childbirth initiative. Preference will be given to lead organizations based in sub-Saharan Africa or Southeast Asia.

The following activities and organizations are not eligible for MSD for Mothers funding support:

- Activities or organizations that directly influence or advance MSD's business (commercial) or marketing interests, including purchase/influence of purchase of MSD products
- Political organizations, campaigns and activities
- Engagement/payments of government officials and government agencies (which in many cases could include hospital employees in government-run facilities)
- Payments/incentives/benefits going to health care providers or facilities (including teaching hospitals)
- Major infrastructure improvements
- Purchase of supplies or equipment unrelated to this project or program
- Direct clinical care and purchase of pharmaceutical products
- Payment of staff salaries or other costs not involved in this project or program
- Organizations that discriminate on the basis of race, ethnicity, gender, sexual orientation, marital status, religion, age, national origin, veteran's status or disability
- Robust governance and final controls, including two years of audited financial statements

SUBMISSION OF EXPRESSIONS OF INTEREST

Applicants should submit their Expressions of Interest via email to CSTMFORMOTHERS@msdformothers.com by November 15, 2021 at 11:59PM ET. It is the applicant's responsibility to ensure that files are complete and transmitted by the deadline. The applicant bears full responsibility for data errors or omissions.

Review & Notification Process

Applicants may submit any questions about the Call for EOI by October 4, 2021 by 5:00pm ET to CSTMFORMOTHERS@msdformothers.com. A call will be organized to respond to all questions in October.

A selection committee will review all Expressions of Interest. MSD for Mothers will notify applicants of the status of their application on December 15, 2021.

Selected organizations will be invited to submit a full proposal. Full proposals will be due March 31, 2022.
